Call for urgent action and debate on the global financing gap for development at the upcoming informal meeting of ministers for development policy

We, the undersigned Members of the European Parliament, call to include on the agenda of the informal meeting of ministers for development policy 10-11 February 2025 the US' budget cuts under USAID, and to propose concrete actions on the global financing gap for development.

The decision by the Trump administration to freeze billions in US development aid is not only having an immediate impact on vulnerable populations and aid workers worldwide, it directly threatens numerous values we hold at the core of our European democracy. With an annual budget of over \$40 billion, USAID is one of the largest organisations dedicated to development aid, reaching 160 countries and regions. Among its highest recipients are the Democratic Republic of Congo and Ukraine. USAID even works within the European Union to assist in shoring up our democracies against external threats. It also makes crucial contributions in all EU candidate countries, where USAID funds contribute to the implementation of EU acquis.

USAID contributes to global development, and much more. It provides vital support for rule of law, elections, democracy, anti-corruption, fundamental freedoms, protection of human rights, and the environment to name a few critical areas.

The reform of USAID and the announced budget cuts are not isolated issues; they are part of a global trend of backtracking on development aid, marked by significant reductions in Official Development Assistance (ODA) budgets. This includes vast cuts to development budgets in EU Member States. Reducing ODA budgets has dire consequences for NGO presence and contributes to the shrinking of the civic space, further risking the creation of opportunities for destabilizing actors to fill the void. In the current global context, we need strong international partnerships based on our shared values.

As it becomes clearer which USAID programs will receive reduced funding or be entirely discontinued, it is imperative for the EU and its Member States to show solidarity with people in need, NGOs and aid workers. We ask the EU to take a strong stance in favour of solidarity and strong relations with other countries.

We therefore call on the European Commission, and the Member States to

- Address this issue with priority during the upcoming informal meeting of ministers for development policy, engage in discussions on the matter in other relevant sessions;
- Make an inventory of the present and potential global impact of the full package of announced cuts, through the network of EU Delegations;
- Urge Member States to follow through on their commitments, such as the 2030 Agenda for Sustainable Development and the 0.7% UN target for ODA, and provide concrete steps on how to achieve these targets;
- Increase efforts to bridge the global financing gap on development aid, through cooperation
 with partner countries and by showing solidarity with people in need globally.
