Honorable High Representative,

Following the capture of El Fasher on 26 October 2025 by the Rapid Support Forces (RSF), violence has escalated in Sudan, the country already afflicted by the gravest of human atrocities. Reports of mass killings, summary executions, systematic sexual violence, torture, and ethnically targeted attacks illustrate a severe further deterioration of the situation for civilians and continue to undermine regional stability. We therefore call upon you to without further delay trigger the procedure to evaluate whether the actions of the RSF fulfil the criteria for their inclusion on the EU's restrictive 'terrorist list', a necessary step in the path towards stability in the region.

The European Parliament has condemned the current developments in Sudan in its Resolution adopted last November 27th. The atrocities committed are severely damaging Sudan and causing immense harm to its population, the consequences of which will last for generations. Beyond acknowledging and condemning these crimes, the actors responsible for such violations should be held accountable.

The EU institutions have the power to list individuals, groups and entities as terrorist. The European Parliament calls on you, as the chair of the Council on Foreign Affairs, to incite the inquiry whether the actions by the RSF, including the targeted attacks on civilians, constitute to acts of terrorisms, and, if justified, proceed to a unanimous designation by the Member States on the inclusion of the RSF in the EU's terrorist list.

There is no option for delay for the people of Sudan. Therefore, we urge you to address this at the Council meeting today, 15 December 2025.
